Property Taxes & Assessments: (FOR NEW BUYER ONLY)

Please notify the proper taxing authority in your municipality of the change in ownership to ensure that all future tax statements and/or assessments be mailed to you.

Driver's License/Voters Registration:

You may wish to change the address on your driver's license. Please visit your local Secretary of State office. If you are relocating from out-of-state, be sure to change your driver's license within thirty (30) days to avoid possible fines. To find an office near you please visit www.michigan.gov/sos. If you move within the same community there is no need to change your voters registration. Simply notify the City Clerk of the change of address. However, if you move from one community to another, you must re-register with the appropriate City Clerk or at any Secretary of State office.
